



HAIDLMAIR GROUP surpasses the €100 million revenue mark for the first time

The HAIDLMAIR GROUP, a corporate group comprising ten companies in four countries with headquarters in Nussbach, Upper Austria, achieved revenue of over 100 million euros for the first time in its history during the 2025/2026 fiscal year. This milestone is a strong sign of the group's sustainable, healthy development, especially against the backdrop of a challenging global economic environment.

The increase in revenue is the result of a consistent focus on the respective strengths of the individual group companies. The largest company in the group, HAIDLMAIR GmbH from the Kremstal region of Upper Austria, made a significant contribution to this. The world-renowned mold maker significantly increased its revenue during the same period, driven in part by its storage & logistics containers product division, which has developed into a particularly strong and rapidly growing business segment in recent years. The positive trend in this area continues unabated, and further revenue growth is expected in the coming years.
